SCHEDULE OF FEES

This Schedule of Fees is effective as of 1 April 2023 and is applicable to all arbitrations and mediations commenced on or after 1 April 2023.

A reference to "dollars" or "\$" is to Australian currency. All fee amounts set out in this Schedule exclude GST (to the extent that it is payable). ACICA may gross up any payment for a taxable supply under its Rules on account of GST. ACICA reserves the right to recover GST from a party at a later date if the GST treatment of a supply is subsequently determined to be incorrect.

Any bank charges incurred on any transfer of funds by the parties to ACICA shall be borne exclusively by the party or parties transferring the funds.

over \$100,000,000	\$57,500 plus 0.025% of the amount in dispute above \$100,000,000 up to a maximum of \$80,000

\$250,001 to \$500,000	\$2,275 plus 1.15% of the amount in dispute above \$250,000
\$500,001 to \$1,000,000	\$5,150 plus 0.75% of the amount in dispute above \$500,000
\$1,000,001 to \$2,000,000	\$8,900 plus 0.5% of the amount in dispute above \$1,000,000
\$2,000,001 to \$5,000,000	\$13,900 plus 0.3% of the amount in dispute above \$2,000,000
\$5,000,001 to \$10,000,000	\$22,900 plus 0.25% of the amount in dispute above \$5,000,000
\$10,000,001 to \$100,000,000	\$35,400 plus 0.02% of the amount in dispute above \$10,000,000
over \$100,000,000	\$53,400 plus 0.025% of the amount in disputes above \$100,000,000 up to a maximum of \$80,000

Maximum administration fee (Appendix A, part 2.2(d) of the ACICA Expedited Arbitration Rules): \$80,000

Appendix A to the ACICA Mediation Rules

Registration Fee

When submitting a Request for Mediation, the party submitting the Request shall pay to ACICA a registration fee of: \$1,000.

In the case of a mediation in which the claims of more than one aggrieved party are consolidated, ACICA may in its absolute discretion charge each party: \$500.

The registration fee is not refundable.

Administration Fee

The parties shall pay to ACICA an administration fee. This fee will be fixed at ACICA's discretion and is dependent on the tasks carried out by ACICA. Such administration fee shall not exceed a maximum sum of \$5,000.
